

Terms and Conditions

DEFINITIONS

For the purposes of these Terms and Conditions of attendance:

"The Event" means the Primary Care Masterclass.

"Organiser" means Prostate Cancer UK.

"Delegate" means an individual, whether part of a group or otherwise, by whom, or on behalf of whom a booking has been made which has been confirmed by the Organiser and who is entitled to attend The Event.

"Substitution" means any circumstance where a Delegate who has paid in full is unable to attend The Event and arranges for another individual to attend The Event in their place, in agreement with the Organiser.

- 1. By registering for and/or attending The Event, all Delegates agree to be bound by, and comply with, these Terms and Conditions. It is the Delegate's responsibility to read and understand these Terms and Conditions in order to attend The Event as a Delegate.
- 2. A Delegate place at The Event will be confirmed on completion of your online registration and within five working days via email on receipt of a paper registration form.
- 3. Delegate places at The Event are limited. Places are subject to availability.
- 4. Food and refreshments are provided at the event. Any special dietary requirements are to be notified in writing by email or post to the Organiser UK at least five working days in advance of the event, all dietary requests will be requested but can not be guaranteed. Please contact the Organiser for clarification.
- 5. All cancellations must be made in writing by email to hpeducation@prostatecanceruk.org, or by post to Prostate Cancer UK, Counting House, 53 Tooley Street, London, SE1 2QN.
- 6. Failure to attend on the day without required notice, or cancellations received less than five working days before the start of the event will be subject to a £75.00 administration fee. The Delegate will be automatically invoiced and the invoice must be paid within 30 days of the event.
- 7. Substitutions can be requested by giving written notice to the Organiser.
- 8. In the event of fire, flood or without limit other causes that the Organiser reasonably believes to be substantial or that are beyond the Organiser's control, the Organiser reserves the right to change the times, dates and the venues of The Event, without incurring any liability to you.
- 9. The Organiser at its sole discretion, reserves the right to change any and all aspects of the Event, including but not limited to, the Event name, themes, content, program, speakers, performers, hosts, moderators, venue, and time.

- 10. By attending the Event Delegates acknowledge and agree to grant the Organiser the right at the Event to record, film, photograph, or capture Delegates likeness in any media now available or hereafter developed and to distribute, broadcast, use, or otherwise globally to disseminate, in perpetuity, such media without any further approval from Delegates or any payment to Delegates. This grant to the Organiser includes, but is not limited to, the right to edit such media, the right to use the media alone or together with other information, and the right to allow others to use or disseminate the media.
- 11. These Terms and Conditions shall be governed by and construed in accordance with English law and each party irrevocably agrees to submit to the exclusive jurisdiction of the English courts.
- 12. These Terms and Conditions, together with the registration form, constitute the entire agreement of the parties. In entering into this agreement, the parties have not relied on, and shall have no remedy in respect of, any statement, representation, warranty, understanding, promise or assurance (whether negligently or innocently made) of any person other than as expressly set out in this agreement. Each Delegate shall be deemed to have full knowledge of the Terms and Conditions and shall be bound by them in all respects.
- 13. To the full extent allowed by law and insofar as it is reasonable to do so, the Delegate agrees not to hold the Organiser liable for any damage or loss suffered or incurred by the Delegate during the course of The Event, including consequential (i.e. losses which are not incurred as a direct consequence of the event leading to any claim) or indirect losses or loss of profit, through registering for The Event, attending The Event, alteration of The Event schedule, cancellation of The Event, or any error or omission on the part of the Organiser.
- 14. The Delegate by accepting these Terms and Conditions hereby indemnifies the Organiser and its servants and agents against and hold it harmless from all or any loss or damage, injury, actions, proceedings or claims arising from any act or omission of the Delegate during the course of The Event.
- 15. Delegates are responsible for taking appropriate insurance cover in connection with their attendance at The Event. Where the Delegate is travelling from outside of the United Kingdom to attend The Event, appropriate travel insurance should be purchased independently and in advance of any travel or travel bookings.
- 16. The Organiser is committed to protecting the privacy of Delegates while providing a personalised and valuable service. Collecting personal information (use of the website assumes Delegate consent) is necessary if the Organise are to satisfy the expectations and requirements of the users e.g. by communicating with them and providing an interactive service. This statement is made to satisfy the requirements of the Data Protection Act 1998 and Prostate Cancer UK is the data controller of Delegate information for the purposes of the Act. The maximum aggregate liability of The Organiser for any claim in any way connected with, or arising from, the Event or this Agreement, whether in contract, tort, or otherwise (including any negligent act or omission), shall be limited to the amount paid by Delegates to The Organiser under this Agreement.
